## TO ALL REGISTRATION HOLDERS OF AGRICULTURAL REMEDIES

### RENEWAL OF AGRICULTURAL REMEDY REGISTRATION

Kindly note that some of your Agricultural remedies registration(s) is/are valid until **31 May 2012**.

With reference to the **2012/2015** registration cycle, please note the following:

#### RENEWAL: FORM A

- a) **Form A** must be completed in triplicate.
- b) Each product that is to be renewed must be depicted on **Form A**.

Attached is the **Form A** on which you are requested to list all product(s) that you wish to renewed. Please indicate on the list with an **X** status of these products(s). The office of the Registrar is not responsible for the errors or omissions.

(c) Authentic signatures are requested on **Form A** and it is essential to complete the declaration on the reverse side.

#### CANCELLATION: FORM B

**Form B** must be completed in duplicate in respect of the agricultural remedy of which the registration shall not be renewed. The original registration certificate of the registration to be cancelled must be returned to the Registrar's office for record purposes. Should the original registration documents be lost, a sworn declaration to this effect must accompany the renewal form.

Form C must be completed in duplicate and returned.

## APPLICATION FEE

The prescribed application fee of R 3 500.00 must be payable to the **Director-General: Agriculture, Forestry and Fisheries** either by **Cheque**, or **Electronic Payment**. Electronic payment details are as follows:

The application for renewal, whether it be by post or hand must be accompanied by an application fee of **R3 500.00** per product and should reach the **Registrar's Office** not later than **16:00 Thursday, 31 May 2012**.

## LATE APPLICATIONS

An application for renewal received after **Thursday, 31 May 2012** will only be considered if it is received not later than **16:00 on Thursday 30 June 2012** and accompanied by additional late application fee of **R 2 450.00** bringing the total amount to **R 5 950.00** per product.

Application for renewal received after **Friday 29 June 2012** will not be considered. Such applications will be considered as new applications. It must be noted that an agricultural remedy that was registered and previously shall not necessary be acceptable for registration again or that the same registration number will be allocated.

## CONDITIONS FOR RENEWAL

A renewal of registration will only be granted subject thereto that:

- Renewal for daughter registration should be accompanied by a signed contract,
- The formulation of the agricultural remedy concerned does not deviate from the existing formulation as registered,


- The particular and wording approved for a label or container used in connection with the sale of the agricultural remedy concerned, has not altered without the prior written approval of the Registrar,
- The registration concerned shall not be in any manner or circumstances be transferable, and
- The immediate container sizes shall not be altered without prior approved from the Registrar.
